

CINCINNATI CONCOURS d'ELEGANCE JAY LENO GARAGE TOUR RAFFLE

Official Rules & Regulations

By participating, you agree that:

These Official Rules & Regulations govern the conduct of the raffle and, together with the decisions of CINCINNATI CONCOURS D'ELEGANCE FOUNDATION (Hereinafter "Cincinnati Concours") are binding on everyone who purchases a raffle ticket and/or who is named on a raffle ticket. The Cincinnati Concours d' Elegance Jay Leno Garage Tour Raffle is a fundraising activity conducted by the Cincinnati Concours in support of Cincinnati Children's Rheumatology Department. These Official Contest Rules may not be waived, modified or supplemented unless such waiver, modification or supplementation is made in writing by the Cincinnati Concours.

GRAND PRIZE DRAWING: The Grand Prize drawing for the Cincinnati Concours d'Elegance Jay Leno Garage Tour Raffle will be held on Sunday, June 10, 2018, at approximately 2:00 p.m. at the Cincinnati Concours d'Elegance awards stage on the lower main show field at Ault Park, 3600 Observatory Ave., Cincinnati, Ohio, except this date and all other dates stated in these rules may be extended at the absolute discretion of the Cincinnati Concours. Ticket requests by mail or on line must be received by Wednesday, June 6, 2018. Tickets may be purchased at additional events and locations to be determined, until approximately 1:00 PM EDT, Sunday, June 10, 2018. Tickets may sell out before that time. The winning ticket will be drawn at random from a drum containing all eligible raffle tickets. The drawings for prizes are open to the public; however the winner does not need to be present to win.

The price per ticket is \$100.00. A maximum of 500 tickets will be sold. Ticket sales will cease when the maximum number of qualified entries is reached. Any requests and payments received following the cut off time or after the sale of 500 tickets will be returned to the sender. The ratio of prizes to tickets is approximately 1 to 500 if all tickets are sold.

GRAND PRIZE: The Cincinnati Concours does not undertake to give advice on the legal or tax consequences of the raffle, or its winner. However, it understands that the IRS position is that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions.

Museum contacts will be provided to the winner for purposes of scheduling tours. Tour availability may be subject to museum restrictions.

Your ticket number(s) will be sent to you by US mail; the ticket stubs will be completed with your contact information and placed in the drawing container. If the credit card transaction is denied for any reason or your check does not clear the bank, no ticket shall be sold and the ticket purchase request is null and void. The purchaser will be notified immediately of the problem and the next ticket order in line will be processed.

The Cincinnati Concours will place each completed raffle ticket stub in the secured raffle barrel located at the offices of the Cincinnati Concours d'Elegance Foundation in Cincinnati, Ohio, and mail the ticket(s) to the purchaser.

TICKET AND PAYMENT VERIFICATION: The Cincinnati Concours reserves the right to reject any ticket request that is submitted with payment that does not constitute "good funds".
